
Dear Sir,

We make use of the current to your honour of the possibility to be realized by the Laborato ry of Cientific Investigation FBI in the Unitd States, test of DNA in materials vinculated to a crime of death committed in a child. This event has the following characters:

- name of the victim : EVANDRO RAMOS CAETANO
- born in 12 setember 1985
- date (day) of the crime: 07 abril 1.992.
- Day that the corpse was found : 11 abril 1.992.
- motive of the death: "MECANIC SUFFOCATION "- strangled-CONDITIONS THAT THE CORPSE WAS FOUND: corpse with impregnati on hematinic of the whole tissue due to the colorative fase of putrefaction in the infiltrative periods, coloration and qualitativ.
- bruises "corto-contusas" with edge carved in bisel localized in the anterior regions (or areas) of the torax and abdome in the lateral limits, superior and inferior parts of the body.
- incomplete absence of the visceras
- absence of the hands on the level of the fists.
- absence of the toes
- parcial absence of the intra-toracic organs.
- absence of "escalpo" (hair)
- absence of penis

We make clean that the death of the minor has happened during a black magic ritual, where the victim was sacrified with the purpose of "to bring fortune and power" to the executers. In the place of the sacrifice and in the house of the one of the executers were found the following materials contained spots with bood aspect.

Ol-ceramic bowl

02-knives

03-wodden hammer

The possibility of being compa red the results of DNA tests in these materials with material collect from the biological parents of the minor Evandro will proportionate secure evidences against the accuseds.

The elucidation of this can contribute to the solution of the disappearance of the ano ther two children of the same age and the same fisical charac ters of the minor Evandro.

If possible the realization of the DNA exams we solicit information in respect of the ses of the exams, adequate form to condition the materials and address where they can becsend to.
